III. RULES AND REGULATION OF THE SOCIETY

V. BY- LAWS : ACTIVITIES OF THE SOCIETY.

- c. The president of the society is the person authorized to give direction in regard to the business of the society
- d. The Society is formed with no profit motive and commercial ability is involved in its working.
- e. The society would not engage in any political communal or additional activities.
- f. The office bearers of the society do not receive any remuneration from the funds of the society.

VI. ENROLLMENT OF MEMBERS.

A. QUALIFICATION: Any person irrespective of caste, creed, community, belief, sex, social standing eligible if he or she above 18 years to become a member of this society.

- a. Person aspiring for membership of the society.
- b. Should subscribe whole heartedly to the promote the aims and other activities of the society.
- c. Should participate in all the Meetings, functions and other activities of the society.
- d. Should not be the membership or the good will of the society in any way, to further personal aspirations.


B. CLASSIFICATION

- a. Member any person who pays in annual subscription of Rs.25/- to the society shall be on ordinary members.

VII. ENTRANCE FEE

Member of the society may be required to pay such other fees for the course and other activities conducted by the society Entrance fee is Rs.60/-.

IX. PAYMENT OF SUBSCRIPTION;

The Annual subscription fees Rs.25/- of the ordinary members shall be paid with in 10 days of the beginning of the financial year of the society. A penalty of Rs.1/- will collect from the defaulting members for a period of 30 days after the expiry of due date.

X. REMOVAL OF MEMBERS

Any Member of the Society may be removed from the roll of the Society.

- a. A Member is found detrimental to the aims and objectives and the society good name of the society.
- b. A member who does not attend three consecutive meetings of the society.
- c. A Member who does not pay annual subscription with in the specific period.
- d. A member who misuses the funds of the society.
- e. A member who make up of the membership and the goodwill of the society for personal benefits.

XI. PROCEDURE FOR REMOVAL MEMBERS.

The member of the society may be removed from the roll of the society.

- a. Member who is found detrimental to the aims and objectives and the good name of the society.
- b. A Member who does not attend three consecutive meetings of the society.

- e. It shall be competent for them to form an advisory Board and elect person of distinction a member of the Board from among the members of the society.
- f. It shall be competent for them to form special committee and elect member from among the members of the society to take charge of various special purpose activities of the society.
- g. The Governing body shall appoint a qualified auditor to audit the accounts of the society and other instructions give by him. The audited receipts and expenditure account and the balance sheet shall be planned before the general body of the society with in six month of the expiry of the financial year of the society and the same along with the documents specified in the act, shall be filled with the concerted.
- h. The governing body shall the accounts of the society when even it meets.
- i. All the properties and assets of the society shall vast in the governing body. All acquisitions and disposals of the property and investment should be approved by the governing body.

XV. POWERS AND FUNCTIONS OF THE GOVERNING BODY

- a. All the affairs of the society shall be managed and its funds controlled by the governing body.
- b. To achieve the objective of the society the governing body is competent to receive funds by subscription, contribution, donation and other gifts by purchasing, taking lease to the rise acquiring and also by letting or other properties for the benefits of the society.
- c. It shall be competent for them to carry out such other Activities as would be of general importance to all its members and those incidental or conducive to the attainment of the objectives of the society.

- e. It shall be competent for them to propose additional Bye/laws from the time to time, consistent with those rules.
- f. It shall be competent for them to make all arrangements for carrying out the objective of the society and in such a expenditure as may be necessary for the attainment for the aims of activities and purpose of the society.
- g. It shall be competent for them to appoint employees of the society as required, under conditions of service, in accordance with the act.

XVI. POWERS AND DUTIES OF OFFICIAL BEARERS

C. TREASURE:

XVII .MEETING

XIX. AN APPLICATION AND ON PAYMENT.

XX. FUNDS

All the funds of the society shall be deposited in any nationalized bank in the name of the society and accounts shall be operated by the Secretary Treasurer by joint account.

XXI. HELP TO THE SOCIETY'S MEMEBRS

The governing body shall appoint the clerk by the direction of the governing body members. They should choose other or from the governing body members.

XXII. EXTRA - ORDINARY MEETING

An extra ordinary meeting of the General Body may be convened by the Secretary and the president at the request of not less $\frac{2}{3}$ of the total not defaulting member of the general body and day's clear notice within one month of the date of application by the member.

The governing body shall hold a meeting at least once in every three months. It shall also be competent or the governing body to take decision by circulations and they will of the majority shall prevail.

XV. FINANCIAL YEAR

XXVI. RESOLUTION

For the resolution of the society the secretary shall be asked to convenience a general body meeting for rectification approval and acceptance of the resolution for dissolution of the society by the vote of not less than three fourth of and defaulting members of the general body present convenienced for the purpose, provided that the total number of voting members then on release. If the general body accept the resolution of dissolve the society the same shall be communicated to the society.

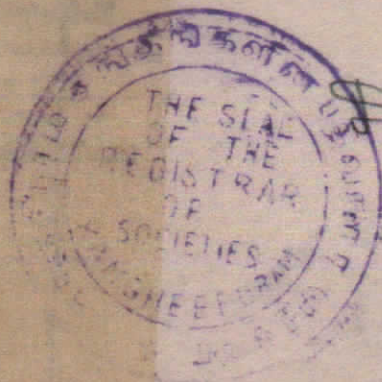
